Made possible by the generosity of individual and corporate donors, our programs bring together physicians, businesses, health care providers, academic institutions and community leaders to help solve our country's most difficult health care challenges.

### ***Community Health Programs***

Provides charitable grants to financially support innovative partnerships of physician-led and community-based agencies, including free clinics focused on the prevention and management of chronic diseases among vulnerable populations. These grants are offered for \$40,000-\$60,000 and are potentially renewable for up to three years.

### ***Excellence in Medicine Awards***

Recognizes physicians who exemplify the highest values of volunteerism, community engagement, leadership and dedication to the care of underserved populations.

### ***LGBTQ Fellowship***

Develops a cadre of physicians to address the specific health care needs of the LGBTQ community and help relieve the current shortage of providers who are knowledgeable and culturally competent in LGBTQ health.

### ***Leadership Development Institute***

Offers a unique leadership development program that includes a weekend retreat, mentorship pairing and additional networking opportunities for students in their final year of medical school.

### ***Physicians of Tomorrow Scholarships***

Provides scholarships to a diverse group of medical student leaders committed to serving their communities and improving our nation's health.

# Giving Back

The AMA Foundation Excellence in Medicine Awards program annually recognizes physicians who exemplify the highest values of volunteerism, community engagement, leadership and dedication to the care of underserved populations. In June 2019, six outstanding physicians were invited to Chicago to be honored at an awards ceremony. The award includes the opportunity to select a health-focused non-profit organization to receive a \$2,500 grant honorarium. In 2019 the recipients were:

**Pedro J. Greer, Jr., MD, FACP, FACG: Pride in the Profession Award.** This award honors physicians who aid underserved populations in the United States.

**Maurice Lee, MD, MPH, FAAFP: Dr. Debasish Mridha Spirit of Medicine Award.** Made possible by Debashish Mridha, MD. This award recognizes the work of U.S. physicians who demonstrate altruism, compassion, integrity, leadership, and personal sacrifice while providing quality health care to destitute, distressed, or marginalized population in impoverished communities.

**Laura Liberman, MD, FACR: Dr. Edmond and Rima Cabbabe Dedication to the Profession Award.** Made possible by Edmond Cabbabe, MD and Rima Cabbabe. This award honors physicians who demonstrate active and productive improvement to the profession of medicine through teaching, research, scientific publishing, leadership, uncompensated services and philanthropy.

**Robert N. Peck, MD: Dr. Nathan Davis International Award in Medicine.** This award honors physicians for outstanding international service in the areas of medical practice, medical education or medical research.

**Susan Sordoni, MD: Jack B. McConnell, MD Award for Excellence in Volunteerism.** This award honors senior physicians (over 55 years old) who are committed to providing medical care to those without access to health care in the United States.

**Richard Allen Williams, MD: Humanitarian Award.** This award was created by the AMA Foundation Board of Directors and is selectively awarded to those individuals who have shown a life-long dedication to the service of patients and advancement of equity in health care.

## *Paying it Forward*

---

This past June at the AMA House of Delegates Annual Meeting in Chicago, delegates joined forces to support future medical leaders and community organizations in a big way.

Dr. Hugh Vincent, a retired Anesthesiologist and AMA House of Delegate Member, traveled from his home in Mill Valley with a special surprise for those in attendance. During the opening remarks of the AMA Foundation Board President, Dr. Patricia L. Austin, Dr. Vincent approached the microphone unbeknownst to of his former peers.

A longtime supporter of the AMA Foundation, Dr. Vincent started by saying, “When we take from the well, we have an obligation to replace that well. And there is no well for me that had more importance in my life, that shaped my career and shaped my life then the well of education.” He went on to share that medical students are coming out of school with unbelievable amounts of debt, presenting insurmountable challenges, so it is easy for him to pay it forward through his contributions to the H. Hugh Vincent, MD Family Fund.

However, he wanted to do more. Dr. Vincent announced that he came to the meeting to personally challenge the house and match every donation made during the meeting, **dollar-for-dollar**, up to \$175,000. He was greeted with a resounding standing ovation.

What happened next was unprecedented. The challenge was so effective that Dr. Vincent increased his matching gift challenge to a total of \$190,000. Not only did attendees exceed his extended challenge, they surpassed it and raised **nearly \$500,000** to support medical students and community health programs nationwide.

Dr. Vincent summed up the experience in a short phrase: “It was a magical moment.”



# ***New \$10,000 scholarship made possible by Illinois physicians***

The AMA Foundation will have a new addition to the Physicians of Tomorrow Scholarship portfolio: the Illinois Physicians of Tomorrow Scholarship. For the last several years, a group of 14 doctors and spouses, led by long-time Illinois family physician Dr. William Kobler, past AMA Foundation Board President and current member of the AMA Board of Trustees, have been working to raise enough donations to fully endow one of the AMA Foundation's \$10,000 scholarships to support an Illinois-based medical student.

This past June, the Illinois Honor Fund passed the \$250,000 threshold to qualify as a separate, named scholarship in the program, which included a generous contribution from the Illinois State Medical Society Alliance. The passion and dedication of the core group – the Founding Donors – to the Illinois Honor Fund, is energizing. “It is so rewarding to work with donors who care so much about giving back,” says Sandi Smith, Director of Advancement at the AMA Foundation. “It was a pleasure to facilitate the discussion on the nuts and bolts creating the scholarship, as well as all of the fundraising initiatives along the way.”

The criteria for the scholarship is simple: applicants must be a resident of Illinois with expressed plans to practice medicine in Illinois after residency, as well as meet the general application requirements. The Physicians of Tomorrow Program awards \$10,000 scholarships to rising final-year medical students at institutions across the country. The current round of applications is live, and this group of physicians is eager to select their first recipient in 2020.

“On behalf of the founding donors,” says Dr. Kobler, “it is an honor and privilege to announce the Illinois Physicians of Tomorrow Scholarship. I want to convey a big **Thank You** to all who contributed to make this possible, but especially the founding donors for their exceptional generosity. We are honored to ‘Give Back, Pay It Forward’ through this scholarship!”
